If you worked in 2023 and your household earned income was less than \$64,000, you may qualify for cash-back tax credits that can increase your refund! **You must file your taxes to claim the credits!**

WHAT DO I BRING WITH ME?

- Photo identification
- Social Security Card or Individual Taxpayer Identification Number (ITIN) Letter for all individuals listed on the return
- W-2s, 1099s and all other income-related documents for 2023
- Form 1095-A, B or C health insurance coverage statement for state return
- All 1098-T and E forms for education expenses
- Childcare provider name, address, phone number and Tax ID Number
- For joint returns, both spouses must be present to sign the required forms
- Account and routing number if you want your refund direct deposited (Recommended)
- Copy of your last year's tax return (Recommended)

DO I QUALIFY FOR CASH BACK?

The California Earned Income Tax Credit (CalEITC), the Young Child Tax Credit (YCTC), the federal EITC, and the new Foster Youth Tax Credit (FYTC) can be combined to put hundreds or even thousands of extra dollars in your pocket.

Current or former foster youth ages 18–25 are now eligible for CalEITC!

The amount of CalEITC you may be eligible for depends on how much money you earn from work. You may be eligible if you:

- Are 18 years or older
- Work for an employer or are self-employed
- Have a Social Security Number or Individual Taxpayer Identification Number
- Lived in California for at least half the tax year

If you qualify for CalEITC and have a child under the age of 6, you may also be eligible for YCTC. You may also be eligible for the federal EITC if you earn less than \$64,000.
