

IT'S THE LAW! BUSINESS RECYCLING

RECYCLING LEGISLATION

Assembly Bill 1826 [AB 1826] will require businesses to separate their food scraps and green waste for recycling. AB 1826 builds on the success of the mandatory commercial recycling program established by AB 341. Please see the timeline below for implementation requirements:

- 2016 – All businesses with 8 or more yards of organic waste per week
- 2017 – All businesses with 4 or more yards of organic waste per week
- 2019 – All businesses with 4 or more yards of solid waste per week

Assembly Bill 341 [AB 341] requires all jurisdictions to meet the diversion goal of 75% by 2020 resulting in businesses that generate 4 or more cubic yards of waste to either:

- Participate in a recycling program with their local waste hauler.
- Donate, sell and/or self-haul materials to a recycling facility.

Assembly Bill 939 [AB 939] required jurisdictions to meet diversion goals of 25% by 1995 and 50% by the year 2000 resulting in the implementation of:

- Drop-off recycling programs
- Curbside recycling
- Commercial recycling
- Construction and demolition recycling

ORGANICS PROGRAM

Returning organic materials to the soil drastically reduces the environmental impacts of landfills, reduces greenhouse gases, creates jobs and helps sustain California's agricultural industry.

Organic collection services for businesses is currently available.

RECYCLE PROGRAMS

MIXED RECYCLING

This program recycles materials such as: cardboard, mixed paper, plastic, aluminum and glass bottles. They may be mixed together and placed in a recycling bin.

SOURCE SEPARATED RECYCLING

Your business may generate a large amount of one type of recyclable material such as cardboard. CR&R can help you determine the best container for your needs based on the quantity and type of material.

CONSTRUCTION AND DEMOLITION

With construction and demolition [C&D] debris making up a large percentage of all material entering California landfills, CR&R can help you to divert as much as possible through a combination of source separation and mixed processing. Does This Affect My Business?

How do I know if my business or multi-family complex will be required to have organic waste recycling?

Initially, most entities that will be required to have organics recycling service will be in the food service industry (such as commissaries, grocery stores and restaurants) or multi-family complexes (that consist of five or more units) with green waste or yard trimmings. But after January 1, 2019, all businesses that generate four cubic yards or more of commercial solid waste per week, regardless of type, must arrange for organic waste recycling services.

1. Does your multi-family complex (with five units or more) generate any green waste, including landscape and pruning waste and non-hazardous wood waste? YES NO



2. Does your multi-family complex currently generate more than eight (8) cubic yards of green waste per week? YES NO

3. Does your multi-family complex currently generate more than four (4) cubic yards of green waste per week? YES NO

4. Does your level of trash service exceed four (4) cubic yards per week? YES NO

If you answered "Yes" to Questions #1, AB 1826 will apply to your business or multi-family complex.

If you answered "Yes" to Question #2 you will need to arrange for organic waste recycling service by April 1, 2016.

If you answered "Yes" to Question #3 you will need to arrange for organic waste recycling service by January 1, 2017.

If you answered "Yes" to Question #4 you will need to arrange for organic recycling service by January 1, 2019.
